

Door Closer Product Limited Warranty

Ten Year Mechanical Warranty: The **DELANEY Grade 1 Door Closer** is covered by a ten (10) year mechanical warranty, which guarantees, to the original purchaser/owner, that the closer shall be free from significant proven defects in material or workmanship under normal usage only, as long as the product used meets the rating requirements for the specific application.

Five Year Mechanical Warranty: The **DELANEY Grade 2 Door Closer** is covered by a five (5) year mechanical warranty, which guarantees, to the original purchaser/owner, that the closer shall be free from significant proven defects in material or workmanship under normal usage only, as long as the product used meets the rating requirements for the specific application.

Upon return of a defective product to Delaney Hardware Inc., Delaney shall either repair or replace (the same or similar model) and return the product to the purchaser/owner at no charge for either parts or labor. This limited warranty does not apply to closers that have been damaged as a result of improper installation, scratches or abrasions, misused products, or residential products used in a commercial application. "Improper installation" includes, without limitation, installation or use of a product in (a) violation of applicable law or code; or (b) any structure for which the product does not have the required rating. A finish deterioration occurring from the use of paints, solvents, other chemicals, or harsh environment is not a defect in the finish and is not covered by this limited warranty. Any closer not found to be defective or covered under this limited warranty will be returned to the original purchaser/owner. Neither the manufacturer nor Delaney Hardware Inc. shall be responsible for any cost of removing the old closer, installing a new closer or any other costs, including the cost or expenses of returning the defective product.

NEITHER THE MANUFACTURER NOR DELANEY HARDWARE INC. SHALL BE LIABLE FOR ANY DAMAGES, INCLUDING WITHOUT LIMITATION, CONSEQUENTIAL, INCIDENTAL, DIRECT, INDIRECT, PUNITIVE OR SPECIAL DAMAGES IN EXCESS OF THE AMOUNT OF THE REPLACEMENT OR REPAIRED PRODUCT, EVEN IF THE MANUFACTURER OR DELANEY HAS BEEN ADVISED OF OR SHOULD HAVE KNOWN OF THE POSSIBILITY OF SUCH DAMAGES. REPAIR OR REPLACEMENT OF THE DEFECTIVE PRODUCT IS YOUR SOLE AND EXCLUSIVE REMEDY AGAINST DELANEY FOR ANY DAMAGES SUFFERED BY YOU.

To the extent allowed by applicable law, including the warranties of merchantability and fitness for a particular purpose, are hereby expressly disclaimed. In the event applicable law does not allow such disclaimer, all warranties imposed by law shall be limited in duration to the duration of the applicable limited warranty provided above. This Limited Warranty is in lieu of all express warranties whatsoever, which are hereby disclaimed.
